2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of clinical characteristics and survival of patients with normal-sized ovarian carcinoma syndrome. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Overall interesting paper, however, in need of improvements. Introduction needs better</p>	[Y]

explanation why the study was done and why is novel. Material and Methods is fine, but the conclusion does not fully reflect the findings and need to be re-written; and (3) Format: There are 5 tables and 4 figures. A total of 16 references are cited, but no references published in the last 3 years were cited. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Elsevier was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Natural Science Foundation of Hubei Province, Hubei Province Health and Family Planning Scientific Research Project, and National Key Technology Research and Development Program of China. The topic has not previously been published in the WJCC. The corresponding author has published 1 articles in the WJCC. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the

original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (6) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (7) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
