The topic is within the scope of the WJD. (1) Classification: Grade C, Grade C, and Grade C; (2) Summary of the Peer-Review Report: The authors examined the association between pulmonary function and T2DM in Korean population, which was conducted properly, and the</p>	[ Y ]

relatively large sample was a strength of the study. However, the language should be revised. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 35 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. The language was edited by a professional English editor. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the STROBE Statement. Institutional Review Board Approval Form and Written informed consent were waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
