The topic is within the scope of the WJMA. (1) Classification: Two Grades C and Grade D; (2) Summary of the Peer-Review Report: In this manuscript entitled "Prevalence,</p>	[Y]

awareness and control of hypertension in Malaysia in 1980–2017: A systematic review and meta-analysis”, the authors reported the pooled prevalence, awareness and control of hypertension in Malaysia from 1980 to 2017. The manuscript is interesting and suitable for the journal. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 106 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade B and Grade C. A language editing certificate issued by Cambridge Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. As shown in the CrossCheck report, the similarity of the manuscript is a little high. Some parts of the manuscript should be revised according to the CrossCheck report. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJMA. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3)

Please add the “Article Highlights” section at the end of the main text; and (4) As shown in the CrossCheck report, the similarity of the manuscript is a little high.
