2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a case report of the twenty-year survival after iterative surgery for metastatic renal cell carcinoma. The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors have presented a very unusual case here and must be commended for the perseverance that they have shown in managing this case, requiring multiple difficult surgeries. is well written and the illustrations are also good. One of the key highlights of this case is that non-surgical therapies still fall short of curative treatment and the role of a surgeon in management of RCC is pivotal. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 5 figures. A total of 54 references are cited, including 30 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please provide the table in a editable format, not in image format; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional
