The topic is within the scope of the WJG. (1) Classification: Grade C; (2)</p> <p>Summary of the Peer-Review Report: This original study evaluated the relationship between HPV infection and alcohol metabolism in</p>	[Y]

patients with early ESCC for the first time and found that HPV status was less important than other risk factors. Although the negative result was delivered, it might draw attention to the association between HPV infection and ESCC. The authors need to explain the lymph node status of the enrolled patients. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 42 references are cited, including 3 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by SES was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The informed consent was waived. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 10%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
