The topic is within the scope of the WJSC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors discuss some aspects of COVID-19 pathophysiology, immunomodulatory mechanisms of</p>	[Y]

MSC, and some clinical trials of cell-based therapy that are ongoing. So several recent reviews already addressing these issues should be added in this manuscript; and (3) Format: There are 2 tables and 1 figures. A total of 97 references are cited, including 28 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The Conflict-of-Interest Disclosure Form is not right. No academic misconduct was found in the Bing search. However, the single-source similarity index showed to be 9%, 8% and 8% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
