The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the</p>	[Y]

Peer-Review Report: The authors indicate that their main objective is to describe a girl with dysmorphic features, intellectual disability and congenital malformations without aniridia, and with microdeletion of 11p13 involving ELP4 gene. The manuscript is very interesting. Some points require further clarification and the manuscript may benefit by adding more focused discussion about the findings. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 18 references are cited, including 0 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by Scribendi Inc was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The written informed consent was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by PAEP, 2018 and PAPIIT IN219419, DGAPA, Universidad Nacional Autónoma de México. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can
