The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: A good manuscript and provides current knowledge on the additional complications of SARS-CoV-2 infection APL antibodies: they appear transiently in most of the infections and do not indicate autoimmune response. Follow-up is important to ensure whether response was transient or autoimmune response. The questions</p>	[Y]

raised by the reviewers should be answered; and (3) Format: There are 1 table and 2 figures. A total of 172 references are cited, including 52 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (4) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
