The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: This paper is a comparative study of pharmacological, non-pharmacological, and acupuncture treatments of IBS. that this paper will assist readers in selecting treatment options for IBS. The authors should include some information regarding the IBS genetics and how genetics may influence the innervations. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 10 figures. A total of 85 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by EnPapers was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the PRISMA checklist form. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 7%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed with 5 financial supports. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures.
