(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The review manuscript deals with rather unique topic, effects of bile acids and cardiovascular tissue, including clinical and experimental, in vivo and in vitro results. However, there are some issues should be addressed. Title is misleading. Go through English-edit by expert in medical writing</p>	[Y]

before re-submission. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 94 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Key R&D Program of Shaanxi. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
