The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is a cutting-edge and hot topic because of the high prevalence of liver diseases. The paper is generally well written. However, the reviewer thinks the focus should be modified, because which is</p>	[Y]

really important is the gut-liver-brain axis. Figure 1 should be modified to include liver-brain interactions and lacking microbial by-products need to be added. Change the title of the article to include liver in the axis. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 120 references are cited, including 61 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China (General Program). The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7
