2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a case report of gastro-duodenal intussusception caused by gastric GIST. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: Authors present a case of gastroduodenal intussusception due to the low-risk gastrointestinal stromal tumor resected by endoscopic intervention with complication. The bibliography is extensive and</p>	[Y]

updated. The case report is well documented, scientifically satisfactory, and describes a rare case; and (3) Format: There is 1 table and 6 figures. A total of 45 references are cited, including 6 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate was provided.

3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the Written informed consent. The author needs to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.

4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the "Abstract" section did not meet our requirements. The "Abstract" section needs to include "BACKGROUND", "CASE SUMMARY" and "CONCLUSION"; (3) I found no "Key Words" section. Please provide the Key Words; (4) I found no "Core Tip" section. Please provide the Core Tip; (5) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation"

	<p>section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision; (6) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (7) Please write the “Conclusion” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked and revised the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
