The topic is within the scope of the WJG. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: In general, this is a scientifically sound and useful retrospective study examining the utility of PSMA as a biomarker for liver cancer, particularly HCC, and as a prognostic marker for anti-angiogenic</p>	[Y]

therapies for liver cancer. The statistics are good, properly using SD. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 5 figures. A total of 33 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and Natural Science Foundation of Hubei province in China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
