The following is our point-to-point rebuttal based on two reviewers's comments. These comments are listed and italicized to distinguish authors' responses for the convenience of reading as below.

Comments from the reviewer 05380317: "The phrase "To the best of our knowledge, this is the first case of AH....." has been repeated four times throughout the manuscript viz, line no. 74, 92, 173 and 213. The authors should avoid such repetition. Otherwise very nicely presented."

Response:

- 1) We have retained the first phrase "To the best of our knowledge, this is the first case of AH reported in the left renal vein" .
- 2) We have deleted the second phrase "to the best of our knowledge, this is the first case of AH reported in the left renal vein".
- 3) We have changed the third phrase "To the best of our knowledge, this is the first case of AH reported in the left renal vein" into "To our knowledge, our case is the first AH to be found in the left renal vein",.

4) We have changed the fourth phrase "To the best of our knowledge, this is the first case of AH reported in the left renal vein" into "Although AH involving the left renal vein branches has also been reported, we presented the first case of isolated anastomotic hemangioma arising from the left renal vein rather than the renal parenchyma"

Comments from the reviewer 02830107: *"The article is interesting due to the anastomosing hemangioma characterized by isolated main left renal vein involvement. However, there is a case report in the literature that is characterized by segmental renal vein involvement, and it is recommended to be included in the discussion. Also in the literature, there are articles on the genetic background and mutations of anastomosing hemangiomas, and the discussion part of the article should be enriched. In line 187, the lack of letters in the word "arterial phase" should be corrected. Numerous radiological images (CT and MR images) and radiological comments were made in the article. Is there a radiologist among the authors? If there is no radiologist among the authors, how do you explain that there are many radiological images (CT and MR images) and radiological comments in the article, but that the authors were not included?"*

Response:

- 1) According to the suggestions of reviewer, we included the case report that is characterized by segmental renal vein involvement in the discussion section.
- 2) We added the genetic background and mutations of anastomosing hemangiomas, and enriched the discussion part of the article.
- 3) We have corrected the word "arterial".
