The topic is within the scope of the WJH. (1) Classification: Grade B, Grade C and Grade D; (2) Summary of the Peer-Review Report: Data regarding the optimal time of paracentesis and outcomes among patients with cirrhosis and ascites are scarce. It's a very interesting topic. However, whether there are other unrelated diseases such as</p>	[Y]

heart disease between EP and DP groups should be further discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 26 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; and (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
