2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a systematic review of the clinical benefit of cyclooxygenase-2 inhibitors in the adjuvant chemotherapy of advanced NSCLC. The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors performed a systematic review base on 12 RCTs on the clinical benefit of COX2</p>	[Y]

inhibitors combined with adjuvant chemotherapy in the treatment of advanced NSCLC patients. This meta-analysis demonstrated that in terms of ORR for patients received adjuvant chemotherapy of advanced NSCLC, COX-2 inhibitors improved the ORR and has no improvement on prolonged mortality. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 9 figures. A total of 40 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Sanming Project of Medicine in Shenzhen. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the
