number of the limitations noting the numbers of recipients in each cohort and hence the limited numbers who experienced the adverse outcomes of interest (i.e., impairment of renal function as well as HCC recurrence). The questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 25 references are cited, including 2 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, the Copyright License Agreement, The Signed Informed Consent Form, and the Institutional Review Board Approval Form. The authors are required to provide the Biostatistics Review Certificate. The highest single-source similarity index in the CrossCheck report showed to be 6%. Please rephrase these repeated sentences. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) The author should number the references in Arabic numerals according to the
