The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The manuscript provides the data of a national study on the correlation between</p>	[Y]

meteorological factors and healthcare utilization related to GERD. The study is original and novel. The study provides new data that have scientific and practical importance. The study has several limitations, however most of them are addressed by the authors in the discussion. The reviewed manuscript requires language polishing. It is not clear whether the start of PPI treatment really a good time point for this purpose. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 37 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Gachon University Gil Medical Center. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the "article
