This could be guiding to future research and clinical application; and (3) Format: There are 2 tables and 1 figure. evaluation: Classification: Grade A and Grade B. A language editing certificate issued by HARRISCO was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Research Foundation of Korea. The topic has not previously been published in the WJH. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) The authors did not provide original pictures. Please provide the original figure documents.
