The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The aim of the study was to evaluate the protective effect of PEG 35 on the pancreatic damage associated to cerulein-induced acute pancreatitis in vivo and in vitro. that PEG 35 could relieve acute pancreatitis, providing a new idea for clinical treatment. It would be more perfect if the author could provide the HE staining pathology of the 3 groups. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 25 references are cited, including 4 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, Institutional Animal Care and Use Committee Approval Form, and the ARRIVE guidelines. No humans are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ministerio de Ciencia e Innovación. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. This manuscript is the resubmission of Manuscript No. 53667. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please provide the original figure documents.
