2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case control study of the best early-onset parkinson dementia predictor using ensemble learning method among sociodemographic factors, parkinson's motor symptoms, parkinson's non-motor symptoms, rem sleep disorder, and neuropsychological profile. The topic is within the scope of the WJP. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript is interesting,</p>	[Y]

and it presents a contribution to the field of machine learning prediction model. However, the sample size calculation should be performed, several typos, misspellings and grammar mistake should be revised. The causal relationship was not further explored. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 6 figures. A total of 35 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Wordvice was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. The Conflict-of-Interest Disclosure Form is not qualified. The STROBE Statement lacks of the page number. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The study was supported by 2 Basic Science Research Programs through the National Research Foundation of Korea. The topic has not previously been published in the WJP. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article
