The topic is within the scope of the WJH. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors demonstrate that HCC incidence is associated with entecavir therapy, and that outcomes vary with HBV</p>	[Y]

genotype. Furthermore, the authors provide an in-depth analysis of long-term observations of the HCC incidence in entecavir treatment groups; and (3) Format: There are 3 tables. A total of 21 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the PRISMA 2009 Checklist. The Conflict-of-Interest Disclosure Form is incorrect. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 9%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Kanagawa Association of Medical and Dental Practitioners. The topic has not previously been published in the WJH. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors the author did not provide an editable table. The table he provided is an image and needs to be provided again; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (4) the author should number the
