The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. A total of 5 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) The authors need to write the "Abstract" section; and (2) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Dermatology.</p>
