2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the hematological scales in alcoholic liver cirrhosis and nonalcoholic fatty liver disease. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: The current manuscript brings an interesting and practical topic in the field of liver diseases.</p>	[Y]

However, there are some limitation in this study. The limitation of the current study should be discussed in the "DISCUSSION" part. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 30 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form, and informed consent. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 10%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (3) the author should number the

The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters.
