The topic is within the scope of the WJG. (1) Classification: Grade A and three Grades B; (2) Summary of the Peer-Review Report: This study investigated the associations</p>	[Y]

between SUA levels and incidence of hepatobiliary-pancreatic cancer. The manuscript is very well designed and the results are interesting. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 5 figures. A total of 47 references are cited, including 18 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Four Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China and Startup Fund for the 100 Top Talents Program, Sun Yat-sen University. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article
