2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the ADAMTS13:AC/VWF:Ag: A biomarker for HAIC treatment. The topic is within the scope of the WJG. (1)</p>	[Y]

Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors have attempted to find an interesting method to predict the response to hepatic arterial infusion chemotherapy in patients with hepatocellular carcinoma. The results of this study may be validated by some other centers also. The language of the manuscript is acceptable with minor polishing. It seems to be a good addition to the existing literature. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 31 references are cited, including 7 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by enago was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Institutional Review Board Approval Form, and informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form and fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 14%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 3

articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
