(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The paper is organized in a clear and easy to understand manner. The problem presented in the paper has been discussed, especially in recent years, but it still remains actual topic. Undoubtedly, the research should be continued, especially as the</p>	[Y]

authors themselves admit that the number of patients included in their research was limited. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 23 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, informed consent, and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Nature Science Foundation Project for Young Scientists of China; the Foundation for Young Medical Talents of Jiangsu Province; Scientific Research Project of Jiangsu Health Commission; and Youth Project of Henan Provincial Health and Health Commission, Ministry of Education. The topic has not previously been published in the WJD. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval

document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (6) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters.
