three different parts: a mini-review of PSIS, a case-report of a patient with liver disease due to PSIS and an overview of the effect of pituitary hormones on the liver. The authors could separate these parts. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 120 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the innovative talent support program of the Institution of Higher Learning in Liao Ning province; and the innovative talents of science and technology support program of young and middle people of Shenyang. The topic has not previously been published in the WJG.
