in children. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Study evaluates the results of the RCT on the effectiveness and side effects of HP eradication regimens in the pediatric population. The authors suggest the need for further research in multicentric controlled studies with well-defined designs in order to change the common practice and recommendations of existing guidelines for pediatric population. Further clarification of the reasons for lower success rated with triple therapy is needed and of the safety profile of antibiotic use in pediatric population. Language needs serious and professional check up. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 56 references are cited, including 11 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 6 articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
