The topic is within the scope of the WJG. (1) <b>Classification:</b> Grade C; (2) <b>Summary of the Peer-Review Report:</b> The authors summarized the current anti-fibrotic drugs well. However, some questions raised by the reviewer should be answered; and (3) <b>Format:</b> There are 2 tables. A total of 112 references are cited, including 37 references published in the last 3 years. There are no self-citations. 2</p>	[Y]

	<p>Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The “Author Contributions” section is missing. Please provide the author contributions. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
