2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the HEV re-infection accelerates HCC development and relapse in a patient with liver cirrhosis. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors present a rare but clinically significant case of liver cancer with HEV infection. The authors</p>	[Y]

provide very detailed case data. However, the chronic HEV infection was undefined for the positive HEV-IgG and negative HEV-IgM but without HEV-RNA positive. Some methodological aspects and results are unclear and should be supplemented. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 27 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, written informed consent, and the CARE Checklist-2016. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study is supported by the SCUT special grant for Global Expert, Guangzhou Science Technology and Innovation Commission, and the Fundamental Research Funds for the Central Universities, SCUT. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all
