The topic is within the scope of the WSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Authors have proposed that collagen sponge-based 3D culture is more favorable for cells to respond to growth factors and demonstrated that TGF-<math>\beta</math>1 is more effective in the tenogenic differentiation of BMSCs compared to GDF-7 and IGF-1. findings are helpful. The experimental plan is properly laid out and significant data are obtained; and (3) Format: There is 1 table and 6 figures. A total of 30 references are cited, including 6 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by Elsevier Language Editing Services was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, The ARRIVE Guidelines, the Institutional Animal Care and Use Committee Approval Form or Document, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Natural National Science Foundation of China, The Science and Technology Research Program of Chongqing Municipal Education Commission, and The Visiting Scholar Foundation of Key Laboratory of Biorheological Science and Technology (Chongqing University), Ministry of Education. The topic has not previously been published in the WSC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section.
