Concentration matters. The topic is within the scope of the WJD. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The study provides current, important information for understanding the content. In addition, it is interesting and necessary in view of the scarcity of reviews on the</p>	[Y]

subject. However, some typo needs to be revised; and (3) Format: There are 4 figures. A total of 67 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form and Copyright License Agreement are not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Polish National Science Centre and NAWA/Campusfrance Polonium. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

Editorial Office Director: I have checked the comments written by the science editor. I have changed the manuscript type “review” to “minireview”.
