already reported in hepatoma cell lines but clinical samples were added to support their issue in this letter. However, the scientific importance or clinic significant of these findings have not been well address. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 7 references are cited, without references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by PSS was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Center for Advanced Studies in Tropical Natural Resources, National Research University – Kasetsart University (CASTNAR, NRU-KU) and the research grant from Kasetsart University Research and Development Institute (KURDI). The topic has not previously been published in the WJH.
