2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes an observational study of the enema-related ischemic colitis. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study was a retrospective study for ischemic colitis after enema administration. This is an interesting study, and the manuscript is well written. However, there are some issues should be addressed. The authors need to</p>	[Y]

reclarify the inclusion and exclusion criteria. In the figure legend of figure 2, the curve was not defined. The clear explanations of the differing part will be better. The authors should describe it. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 34 references are cited, including 1 reference published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
