WJGS. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors compare pancreatoduodenectomy and pancreas-preserving duodenal resection for management of cystic dystrophy of the duodenal wall, or groove pancreatitis. This result has the extremely important clinical significance to the treatment of this disease. However, the figures that are not combined do not meet the requirements. The questions raised by the reviewer should be answered; and (3) Format: There are 9 tables and 6 figures. A total of 46 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
