2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a meta-analysis of the prognostic impact of at least 12 lymph nodes after neoadjuvant therapy in rectal cancer. The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors reported a very nice meta-analysis with a relevant conclusion for modern operative</p>	[Y]

therapy of patients with rectal cancer. However, the evaluation is too superficial for a meta-analysis; more factors influencing the prognosis have to be analyzed. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 6 figures. A total of 51 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The PRISMA 2009 Checklist needs to add the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, and Special Research Fund for the First Affiliated Hospital of Chengdu Medical College. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article
