The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 19 references are cited, including 7 references published in the last 3 years. There are no self-citations.</p> <p>2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE checklist form. The authors need to provide the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
