The topic is within the scope of the WJD. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors of this manuscript have reported the effect of liraglutide on endoplasmic reticulum stress in the renal tissue of type 2 diabetic rats. findings observed in this study appear to be interesting. The majority of data is convincing and supportive for the working hypothesis. However, there are some concerns/questions that need to be addressed. Please summarize your findings in the first paragraph of the discussion for better understanding. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 16 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and Institutional Animal Care and Use Committee Approval Form. The authors need to fill out the ARRIVE Guidelines with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Social development science and Technology project of Shanxi Province. The topic has not previously been published in the WJD. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval

document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (5) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as $aP < 0.05$, $bP < 0.01$ ($P > 0.05$ usually does not need to be denoted).
