liver hardness and constructed a model for predicting liver hardness. The study concluded that Liver stiffness assessed by 2D-SWE and palpation correlated well with durometer hardness values. The new developed model could calculate the durometer hardness values for predicting PHLF. The authors have done too much in the study. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 45 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Key research and development project of science and technology department of Zhejiang, China, and Zhejiang Provincial Program for the Cultivation of High-level Innovative Health talents. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
