(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reports on the reliability of PCR-based test for detecting H. pylori clarithromycin resistance in stool samples. However, the repetitious statement that "H. pylori is closely related to a variety of gastric diseases" should be modified</p>	[Y]

A total of 42 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA 2009 Checklist. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the “New Xiangya Talent Projects” of the Third Xiangya Hospital of Central South University. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The reference’s number cited in the text should be put in the square bracket, then make them superscript. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Not
