The topic is within the scope of the WJGE. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors reported a very</p>	[Y]

comprehensive review on an important topic for endoscopists. The manuscript is well written and structured; and (3) Format: There are 56 tables and 2 figures. A total of 139 references are cited, including 53 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The authors' information, the abstract, the keywords, and the core tip should be added in the start of the manuscript; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
