2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a minireview of the surgical strategies for perianal Crohn's disease. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The study describes the modern surgical management and the most recent advances in the management of complex perianal fistulizing disease. However, the reviewer recommends the authors to mention a possibility of restorative RPC with IPAA technique in some Crohn's colitis patients who have</p>	[Y]

been shown to benefit greatly from RPC with IPAA as herewith referenced with the 3 citations below. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 1 figure. A total of 59 references are cited, including 24 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
