The topic is within the scope of the WJG. (1) Classification: Grade B; (2)</p> <p>Summary of the Peer-Review Report: This is a very interesting manuscript as it proposes a new therapeutic strategy for LAPC. The results section provided the relevant data after this new</p>	[Y]

combination therapy. The discussion section gave emphasis to the new contribution of the study in its field. As a preliminary exploration, this study has better clinical value and application prospects; and (3) Format: There are 5 tables and 2 figures. A total of 30 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by ELIXIGEN was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, written informed consent, CONSORT Checklist form, and the Clinical Trial Registration Statement. The authors need to provide the original Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by International Science Foundation of Affiliated Fuda Cancer Hospital, Jinan University. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the
