angles, centre of gravity displacement, peak pressure values and impulse in the anterior and posterior regions of both the affected and healthy feet. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 4 figures. A total of 52 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Three Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Funded by the Scientific Research Fund of the Educational Department of Liaoning Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the

The authors provided the Clinical Trial Registration Statement and CONSORT 2010 Statement, but didn’t provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
