2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the overlength stents placement after endoscopic papillectomy. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors investigated the usefulness of overlength stents for preventing delayed perforation after EP. The concept of this study</p>	[Y]

seems to be interesting. However, several major concerns were raised. First of all, the indication of EP should be mentioned. Please provide the endoscopic images of exposure or injury of muscularis propria in all 5 cases. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 23 references are cited, including 2 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by BioMed Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4)

	<p>Please write the “Conclusion” section at the end of the main text. 6</p> <p>Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
