manuscript is well structured. However, the language needs to be revised. The questions raised by the reviewer should be answered; and (3) Format: There are 3 figures. A total of 105 references are cited, including 26 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors didn't provide the Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
