fatty liver, but the article does not follow different models how to establish? The article is poorly organized. It is suggested to make a major revision. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 123 references are cited, including 29 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by grant numbers R01 AA026302-02 and P30 DK0503060. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s).
