2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a meta-analysis of the cardiac adverse events of immune checkpoint inhibitors. The topic is within the scope of the WJC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report:</p>	[Y]

This study aimed to estimate the incidence of cardiovascular irAEs among patients undergoing ICI therapy for various malignancies. The study is well design, and the paper is well written. However, there are some issues should be addressed. The Incidence of atrial fibrillation is significant higher than other cardiac complications. The mechanisms for the increased risk of atrial fibrillation should be discussed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 9 figures. A total of 39 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The authors have published preprint (<https://www.medrxiv.org/content/10.1101/2020.06.01.20119719v1>). 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (6) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
