HCC in human beings. Are there many patients with Ehinococcus in this area? The author must write down how many cases have been reported in the literature and conduct a small review. Provide high quality pictures. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 15 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Elixigen was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the Written informed consent. The author needs to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the People's Hospital of Xinjiang Uygur Autonomous Region. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation

Please add “OUTCOME AND FOLLOW-UP” section; and (5) I found the authors did not provide the approved grant application form(s).
